**INVITATION TO BID**

The Romblon Electric Cooperative, Inc. (ROMELCO) thru its Pre-qualification Bids and Awards Committee (PBAC) invites accredited/eligible suppliers/manufacturers to submit bid for the Supply of Electrical Equipment and Other Materials for the Construction of Distribution Lines for thirty (30) sitios in ROMELCO's coverage area. The said project will be funded from the proceeds of Subsidy Releases from the National Electrification Administration (NEA) for Sitio Electrification Program in the amount of Twenty Three Million Eight Hundred Eighty Two Thousand Three Hundred Fifty One Pesos & 71/100 (PhP 23,882,351.71) and Four Million Nine Hundred Sixty Two Thousand Nine Hundred Pesos & 79/100 (PhP 4,962,900.79) for the construction of distribution lines and household connections, respectively.
