All bidders for **LOTS 1, 6, 10, 11, 12, 13, 14 & 15** must have a valid Philippine Contractors Accreditation Board (**PCAB**) license and registration for the type and cost of contract to be bid, statement of availability of key personnel and equipment for the prosecution of the contract and should have completed similar contract with a value of at least 50% of the ABC.

ONLY THOSE WHO ARE DULY ACCREDITED AND ARE ABLE TO PURCHASE BID DOCUMENTS ARE ALLOWED TO PARTICIPATE IN THE PRE-BID CONFERENCE (IF EVALUATED TO BE ELIGIBLE). All bids shall be accompanied by a BID SECURITY in the amount equivalent to 2% of the ABC in the form of cash, cashier's or manager's check or bank guarantee only.


