- The Nueva Ecija II Electric Cooperative Inc.-Area 1 (NEECO II-AREA 1) through the 2018 Sitio Electrification Program Subsidy intends to apply the sum of **Php 5,384,078.63** for the Lot 1. Construction/Extension of Distribution Lines for 5 Puroks and Php 311,337.60 for the Lot 2. Kilowatt-hour meters, Service drop wires and Housewiring materials being the Approved Budget for the Contract (ABC) to payments under the contract for each lot.

- The NEECO II- AREA 1 now invites bids for Construction/Extension of Distribution Lines for 5 Puroks and Supply and delivery of Kilowatt-hour meters, Service drop wires and Housewiring materials. Completion of the Works is required until October 2018. Bidders should have completed a contract similar to the Project. Interested bidders must be previously accredited and/or for those interested bidders who may want to participate can be accredited upon full payment of non-refundable accreditation fee of Php5,000.00 which is valid for one (1) year.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- A complete set of Bidding Documents may be acquired by interested bidders from September 3 to September 21, 2018 from the BAC Secretary and upon payment of the applicable fee for the Bidding Documents.
- The NEECO II-AREA 1 will hold a Pre-Bid Conference on *September 10, 2018, 2:00pm at NEECO II-AREA 1 Teofilo Villanueva hall* which shall be open to prospective bidders.
- Sealed Bids must be duly received by the BAC Secretariat on or before *September 21, 2018, 9am at NEECO II-AREA 1 Teofilo Villanueva hall*. All bids must be accompanied by a bid security in any of the acceptable forms stated in the bidding documents. Bid opening shall be conducted immediately after the deadline of submission of bids. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- Sealed Bids shall be submitted in two (2) sealed envelopes clearly marking as "Original Bid" and "Copy of Bid" with the name of the project to be bid and the name of the bidder in capital letter addressed and/or submitted to the BAC Chairman during the Bid Opening at which time and place will be opened and read in the presence of Bidders or their representative. Bid proposals must include terms of payment, bid validity and delivery/construction schedule.
- The NEECO II-AREA 1 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
- Finally, NEECO II AREA-1 assumes no obligation to compensate any bidder or any party for any loss or expense incurred in the preparation of the bid or participation in the bidding process.
