### Invitation to Apply for Eligibility and to Bid for the Supply of Labor and Materials for: Construction of Distribution Lines of Twenty Three (23) Sitios; and Housewiring Connection

1. The **Occidental Mindoro Electric Cooperative, Inc. (OMECO)** through the 2018 Sitio Electrification Program (SEP) GAA Subsidy from National Electrification Administration (NEA) intends to apply the sum of **Twenty Six Million Two Hundred Thirty Seven Thousand Five Hundred Twenty Nine Pesos and 43/100 (PhP 26,237,529.43)** as the Approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. **OMECO** now invites bidders to apply for eligibility and to bid for the **Supply of Labor and Materials for: Construction of Distribution Lines of Twenty Three (23) Sitios; and Installation of kWh Meters, Service Drop Wires, and Housewiring Materials.** Completion of the Works is required completed within **Ninety (90) Calendar Days** including testing and commissioning reckoned from receipt of the Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly in the Instructions to Bidder.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **OMECO** and inspect the Bidding Documents at the address given below from **8:00AM – 5:00 PM (office hours), Monday – Friday (except Holidays)**
5. A complete set of Bidding Documents may be acquired by interested bidders starting on **September 21, 2018 (office hours 8:00AM – 5:00 PM) until October 10, 2018, 9:00 AM** from the address below *and upon payment of the applicable fee for the Bidding Documents, in the amount of Twenty Five Thousand Pesos (PhP 25,000.00)*

It may also be downloaded free of charge from **OMECO** website [site.omeco.com.ph/pbac](http://site.omeco.com.ph/pbac) provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. **OMECO** will hold a Pre-Bid Conference on **September 28, 2018, Friday, 10:00 AM** at **OMECO Multi-Purpose Hall, M. H. del Pilar St. San Jose, Occidental Mindoro**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 10, 2018, Wednesday at 10:00 AM**. All bids must be accompanied by a bid security in the form of Cash or Manager's Check made payable to **OMECO** in the amount of two percent (2%) of the total ABC.

8. Bid opening shall be on **October 10, 2018, 10:00 AM** at **OMEKO Multi-Purpose Hall**, M. H. del Pilar St. San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidder and/or bidders' representatives. Late bids shall not be accepted.
9. **OMEKO** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of 2016 Revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
