1. **THE BUSUANGA ISLAND ELECTRIC COOPERATIVE (BISELCO)**, through its Bids and Awards Committee (BAC) will undertake Alternative Mode of Procurement and invites interested entities to submit their **Price Quotation for the Purchase of the following items:**

 - Certified True Copy of Securities and Exchange Commission (SEC) Certificate or Department of Trade and Industry (DTI) Registration
 - List of works done and respective clients.

Offer /Quotation exceeding the Approved Budget for the Contract (ABC) shall be rejected.

BISELCO reserves the right to accept or reject any offer/quotation, reject all offer/quotation at any time prior to contract award, to exclude any item or reduce the number of unit and the corresponding ABC as determined by BISELCO and to award the contract to the Bidder with most advantageous offer, without thereby incurring any liability to the interested entities.
