Interested bidders may obtain information from the BAC Secretariat at ANECO Central Office and purchased a copy of Bidding Documents from 8:00 Am to 5:00 PM, excluding Holidays, Saturdays and Sundays upon submission of a Letter of Intent (LOI) to the ANECO BAC and subsequent payment of non-refundable Bid Fee.

ANECO also reserves the right to reject any or all bids without disclosing any reason, to waive any minor defects or infirmities therein and to accept such bid as may be considered most advantageous to the cooperative.
