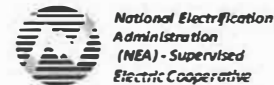

At the abovementioned time the Eligibility Requirements and Bid Proposals will be opened, evaluated and qualified in the presence of bidders or bidders' authorized representative/s. Late bids will not be accepted.
