- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

6. The <u>ILECO III</u> will hold a Pre-Bid Conference on <u>November 16, 2018 – 1:30 PM</u> at <u>ILECO III Board</u> Room, Preciosa, Sara, Iloilo, which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before <u>November 28, 2018 1:30 PM at ILECO III Board Room, Preciosa, Sara, Iloilo</u>. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on <u>November 28, 2018 1:30 PM</u> at <u>ILECO III Board Room, Preciosa, Sara, Iloilo</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. The winning bidder must immediately start the works five (5) days after receipt of Notice to Proceed from the Departmen of Energy. He shall observe safety precautions during the execution of works; and shall be held liable for damages to persons and properties arising from the prosecution of works.
- 9. The <u>ILECO III</u> reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
