

# CAMARINES SUR I ELECTRIC COOPERATIVE, INC.

## INVITATION TO BID FOR THE SUPPLY OF SECURITY SERVICES FOR CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I)

1. The Camarines Sur I Electric Cooperative, Inc. (CASURECO I), through its **General Fund** intends to apply the total sum of **Seven Million Six Hundred Thirty Four Thousand Six Hundred Forty Nine Pesos and Nine Centavos (Php7,634,649.09)** being the **Approved Budget for the Contract(ABC)** for procurement of **Supply of Security Services for CASURECO I /ITBN#CAS1-2018SS**. Bids received in excess of the ABC shall be automatically rejected at bid opening..

2. CASURECO I now invites bids for **Supply of Security Services for CASURECO** with an **ABC of Php 7,634,649.09**. Bidders should have completed a contract similar to the Project at least three (3) years within the last five (5) years prior to the bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Memorandum No. 2017 – 019 Revised Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR 105331 (2017)

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **CASURECO I**, inspect and acquire the Bidding Documents at the address given below on **November 7, 2018 to November 29, 2018 from Monday to Friday from 9:00 a.m. to 5:00 p.m.(except Saturdays, Sundays and Holidays)** and **December 3, 2018 from 8:00 a.m. to 1:00 p.m.**

A complete set of Bidding Documents may be purchased by the **new interested Bidders** from the address below upon payment of a **nonrefundable fee for the Bidding Documents** in the amount of **Ten Thousand Pesos (Php 10,000.00), Five Thousand Pesos (Php 5,000.00) by the previous Bidders**. However, only Bidders who have paid the nonrefundable fee for the Bidding Documents can participate in the bidding.


5. **CASURECO I** will hold a Pre-Bid Conference on **9:30 a.m., November 19, 2018** at Puro Batia, Libmanan, Camarines Sur, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before **1:00 p.m, December 3, 2018**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 17.

Bid opening shall be at **1:30 p.m., December 3, 2018** at the CASURECO I Headquarters, Puro Batia, Libmanan, Camarines Sur. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. All activities related to the bidding process will be conducted at the CAMARINES SUR I ELECTRIC COOPERATIVE, INC. Headquarters, Puro Batia, Libmanan, Camarines Sur.
8. CASURECO I reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
