Bidding will be conducted through Open Competitive Bidding Procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 10531.

Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications. A compulsory attendance during the pre-bid Conference is hereby enjoined.

All bids submitted must be accompanied with a bid security, in the amount equivalent to 2% of the ABC in a form of Cash, Cashier's check, Manager's check.

The duration of contract for the Comprehensive Healthcare Services will be from January 1, 2019 to December 31, 2019.


