(CEBECO I) through the constituted Bids and Awards Committee (BAC), hereby invites all Accredited Manufacturers, Suppliers, Dealers, and Authorized franchised dealers to submit their respective bids for the procurement, supply, delivery, installation, testing and commissioning of equipment and materials for the **replacement of Turbine/ Generator Assembly at Matutinao Mini-hydro Power Plant.**

The submitted documents of each bidder shall be examined and checked for completeness against a checklist of requirements to ascertain they are all present using a non-discretionary "pass/fail" criterion.

All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. Only those bidders who have bought the bidding documents shall be allowed to attend or participate during the pre-bid conference where their presence is **MANDATORY**. There will be absolutely no selling of bidding documents after the pre-bid conference has already been conducted. The prospective bidder must have completed within three (3) years from the date of bid opening a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.
