## INVITATION TO BID FOR SUPPLY & DELIVERY OF 3,886 KWH METERS 10 (60) AMPS.

1. The Iloilo III Electric Cooperative, Inc. (ILECO III) through the budget from NIHE 2018 (DOE) intends to apply the sum of Php 4,829,682.06 (Inclusive of VAT) being the Approved Budget for the Contract (ABC) to payments under the contract for ITB 1806, Series of 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ILECO III now invites bids for KWH Meters. Delivery of the Goods required is Sixty (60) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
