Attendance to the Pre-Bidding Conference is optional. However, matters discussed and agreed by the attending parties are final and irrevocable. All bids and other documents shall be submitted in a sealed envelope addressed to the Chairperson, Bids & Awards Committee, SURSECO-I, and shall be submitted on or before the set time for the Opening of Bids. The bids, together with the required documents, shall be opened on the schedule of the Opening of Bids. The same shall be held at the SURSECO-I Main Office, San Fernando, Bislig City.

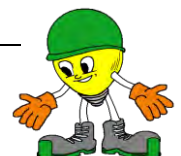
