INVITATION TO BID FOR Procurement of Security and Protective Services for Fiscal Year 2018 - 2019

- 1. The Occidental Mindoro Electric Cooperative, Inc. (OMECO), through the 2018 Cash Operating Budget intends to apply the sum of Three Million Two Hundred Forty One Thousand Five Hundred Twenty Six Pesos and 40/100 (PhP 3,241,526.40) per Fiscal Year being the Approved Budget for the Contract (ABC) to payments under the contract for Security and Protective Services for FY 2018 -2019. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. **OMECO** now invites bidders to apply for eligibility and to bid for the **Procurement for Security and Protective Services**. Delivery of the Services is required **within the Fiscal Year 2018 2019**. Bidders should have completed, within **three** (3) **years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
- 4. Interested bidders may obtain further information from *OMECO Bids* and *Awards Committee* (*OMECO-BAC*) and inspect the Bidding Documents at the address given below during *Monday to Friday*, 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 3, 2017* until *November 23, 2017* from the address below and upon payment of a non-refundable fee for the Bidding Documents, , in the amount of *Ten Thousand Pesos (Php 10,000.00)*
 - It may also be downloaded free of charge from the OMECO website <u>site.omeco.com.ph/pbac</u> provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
- 6. Interested Bidder must express their intention to participate in the bidding through letter of intent submitted to the Bids and Awards Committee not later than the Pre-bid Conference.
 - Attendance of the Bidder or its duly authorized representative during the conduct of the Pre-bid Conference is required.

- 7. OMECO will hold a Pre-Bid Conference on November 10, 2017, 10:00 AM, at OMECO Multi-Purpose Hall, OMECO Main Office, M. H. del Pilar St. San Jose, Occidental Mindoro, which shall be open only to all interested Bidders.
- 8. Bids must be delivered to the address below on or before *November 23, 2017, 10:00 AM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount of two percent (2%) of the ABC.
- 9. Bid opening shall be on *November 23, 2017, 10:00 AM* at *OMECO Multi-Purpose Hall, OMECO Main Office, M. H. del Pilar St. San Jose, Occidental Mindoro*. Bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.
- 10. **OMECO** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
