All bids must be accompanied by a bid security of not less than five percent (5%) of the total bid price or an equivalent amount in a freely convertible currency. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at exactly 2:00 PM (PST) of December 13, 2017.

PENELCO reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
