**Invitation to Bid for Supply of Labor and Materials for the  
Construction of 8 Sitios (7.62/0.24kV Distribution Lines) at  
the Municipalities of Cabusao, Libmanan, Pasacao and San  
Fernando, Camarines Sur.**

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I), through the NATIONAL ELECTRIFICATION ADMINISTRATIONS's (NEA's) 2017 SEP GAA Subsidy intends to apply the sum of Four Million Six Hundred Nine Thousand Eighteen Pesos and Fifty Seven Centavos (Php 4,609,018,57) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Labor and Materials for the Construction of 8 Sitios (7.62/0.24kV Distribution Lines) at the Municipalities of Cabusao, Libmanan, Pasacao and San Fernando, Camarines Sur /CAS1-2017DLS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CASURECO I now invites bids and submit letter of interest for the supply of labor, excavation, clearing and erection/installation of 7.62/0.24kV distribution line for the following:
  - 1) Sitio Looban, Barcelonita, Cabusao, Camarines Sur
  - 2) Sitio Villasan, Castillo, Cabusao, Camarines Sur
  - 3) Zone 3, San Pablo, Libmanan, Camarines Sur
  - 4) Zone 3, Tarum, Libmanan, Camarines Sur
  - 5) Suminabang, Dalupaon, Pasacao, Camarines Sur
  - 6) Zone 3, San Juaquin, San Fernando, Camarines Sur
  - 7) Zone 4, San Juaquin, San Fernando, Camarines Sur
  - 8) Zone 1, Tagbangan, Pipian, San Fernando, Camarines Sur

Completion of Works is required for the duration of Forty (40) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a Philippine Contractors Accreditation Board (PCAB) License Category of at least "C & D" and at least a Size Range of Small B. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR of 2016) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from CASURECO I and inspect the Bidding Documents at the address given below starting November 8, 2017 until November 27, 2017 from 8:00A.M. to 5:00P.M. (except Saturdays, Sundays and Holidays).
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00)
6. The CASURECO I will hold a Pre-Bid Conference on 09:30A.M., November 15, 2017 at CASURECO I, Puro Batia, Libmanan, Camarines Sur, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before November 28, 2017 at 9:00A.M. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
