Bid proposals must include terms of payment, bid validity and delivery/construction schedule.

Further, all bids submitted must be accompanied by a Bid Security equivalent to two percent (2%) of the offer, which is to be returned immediately after the awarding. Bid Security must be in Manager's Check form ONLY.
