Delivery Period: Within 30 calendar days upon receipt of Purchase Order in full delivery for Categories 1, 2, 3, 4, 5, 6, 7, 9, and 10, except Category 8 which is within 60 calendar days. This shall be subject to two(2%) percent withholding tax for the delivery of goods and services. BAC will impose liquidated damages in the amount equal to one tenth(1/10) of one percent(1%) of the cost of the delayed goods scheduled for delivery for every day of delay. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted. All particulars relative to Eligibility Statement and Screening, Bid Security Performance Security, Pre-bidding Conference(s), Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531 (2017) under NEA Memorandum No. 19, Series of 2017.

Bid Documents will be available only to prospective bidders upon payment of a non-refundable amount per category as indicated above.

All bidders/suppliers are requested to attend the Pre-Bidding Conference for the orientation and clarification of the Procurement Guidelines. Prospective bidders who wish to attend the Pre-Bidding Conference must purchase the Bid Documents prior to the start of the said conference.

**BID SECURITY.** The Bidders Bond shall be two (2%) percent of the ABC and shall be in the form of cash, Cashier's check and Manager's check.

**PERFORMANCE SECURITY.** The BAC shall notify the winning Bidder in writing that its Bid has been accepted through a Notice of Award received personally or sent by registered mail or electronically and require the latter to submit a performance security within ten(10) days after the receipt of notification of award of the contract. The Performance Security shall be five (5%) percent of the contract price in the form of cash, Cashier's check and Manager's check to MOELCI-II as compensation for any loss resulting from suppliers' failure to complete its obligation under the contract. Failure of the winning bidders to comply with this requirement shall constitute grounds for the annulment of the award and forfeiture of the bid security.

The MOELCI-II assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.

The MOELCI-II reserves the right to accept or rejects any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
