Delivery of required materials for Lot 1 and Lot 2 should be made within thirty (30) calendar days and delivery and installation of requirements for Lot 3 should be made within ninety (90) calendar days commencing upon receipt of the Purchase Order and Notice to Proceed.

Potential bidders must apply for accreditation by submitting the following requirements before they are allowed to participate in the bidding process.

- DTI Business name registration or SEC registration certificate
- Valid and current Mayor's permit/municipal license
- Tax payer's identification number
- BIR Value Added Tax Registration
- Certification that the supplier/contractor is not black listed or banned from bidding by the government or any of its agencies and other private corporations or ECs
- Compliance with EO # 398
 - Proof of VAT payment for the past six months
 - Tax clearance from the BIR for the last two quarters
- On-going, completed or awarded contract not yet started within the relevant period specifying the following:
 - Name of contract
 - Date of Contract
 - Amount of contract and value of outstanding contracts
 - Date of delivery
 - End-user's acceptance if completed
- Payment of Accreditation Fee of Two Thousand Pesos (P 2, 000.00)

Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. A complete set of Bidding Documents may be purchased starting October 5, 2017 until 4:00 P.M. of October 13, 2017 by eligible bidders upon submission of a written application to the BAC Secretariat at the above address and upon payment of a non-refundable fee of Twenty Five Thousand Pesos (P25, 000.00). Questions and clarifications regarding the bid documents must be submitted on or before October 13, 2017. Pre-bid Conference will be held on October 17, 2017 9:00 A.M. at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on November 3, 2017 not later than 9:00 AM at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
