Bids higher than the ABC shall automatically be rejected.

Prospective Bidders should possess a valid Electrical Work PCAB License applicable to the contract. Bidding will be conducted through open competitive bidding procedures in accordance with the criteria specified in the Implementing Rules and Regulations of R.A. 9184, otherwise known as the Government Procurement Act. Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine its responsiveness to the technical and financial requirements of the project. The contract shall only be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post qualification procedure.

Bidders or authorized representative who failed to attend the pre-bid conference will not be allowed to participate in the bidding. All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid. This bid security shall be valid for at least 90 days starting from the date of bid opening.
