**Invitation to Apply for Eligibility and to Bid for the Extension of Distribution Lines
for Thirty One (31) Sitios and Installation of Kwhr Meters, Service Drop Wires
and Housewiring Materials**

1. The **Occidental Mindoro Electric Cooperative, Inc. (OMEKO)** through the 2017 Sitio Electrification Program (SEP) GAA Subsidy from National Electrification Administration (NEA) intends to apply the sum of **Twenty Million Two Hundred Seventy Four Thousand One Hundred Ninety Three Pesos and 28/100 (PhP 20,274,193.28)** as the Approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **OMEKO** now invites bidders to apply for eligibility and to bid for **Extension of Distribution Lines for Thirty One (31) Sitios and Installation of Kwhr Meters, Service Drop Wires and Housewiring Materials**. Completion of the Works is required completed within **Ninety (90) Calendar Days** including testing and commissioning reckoned from receipt of the Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly in Instructions to Bidder.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **OMEKO** and inspect the Bidding Documents at the address given below from **8:00AM –5:00 PM (office hours), Monday – Friday (except Holiday)**
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 19, 2017 (office hours 8:00AM – 5:00 PM)** until **November 03, 2017, 9:00 AM** from the address below *and upon payment of the applicable fee for the Bidding Documents, in the amount of **Twenty Five Thousand Pesos (PhP 25,000.00)***

It may also be downloaded free of charge from **OMEKO** website site.omeco.com.ph/pbac provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. Interested bidders must express their intention to participate in the bidding through letter and submit at the address below not later that the scheduled Pre-bid Conference.

Attendance of the bidder or its duly authorized representative during the conduct of the Pre-bid Conference is required.

7. **OMECO** will hold a Pre-Bid Conference on **October 27, 2017, Friday, 10:00 AM** at **OMECO Multi-Purpose Hall**, M. H. del Pilar St. San Jose, Occidental Mindoro, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **November 03, 2017, 10:00 AM**. All bids must be accompanied by a bid security in the form of Cash or Manager's Check made payable to **OMECO** in the amount of two percent (2%) of the total bid price.
9. Bid opening shall be on **November 03, 2017, 10:00 AM** at **OMECO Multi-Purpose Hall**, M. H. del Pilar St. San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidder and/or bidders' representatives. Late bids shall not be accepted.
10. **OMECO** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of 2016 Revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
