Bids received in excess of the Approved Budget for the Contract shall be automatically rejected at the Bid Opening.

Bidding will be conducted through competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of the Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act, and is restricted to organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, as specified in Republic Act 5138 (R.A. 5138). Only Bids from bidders who passed the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents. The Bidder/s with the lowest calculated Bid (LCB) shall advance to the post qualification stage in order to finally determine responsiveness to the technical and financial requirements of the project. In case two (2) or more bidders tie in the financial proposals, and are eventually found to be equally post-qualified, “drawing of lots” shall be resorted to as the tie-breaking method in accordance with GPPB Circular No. 06-2005. The contract shall then be awarded to the Lone **Lowest Calculated and Responsive Bidder (LCRB)** determined after Post Qualification, or after the drawing of lots in case of tie.

Bid documents and eligibility requirements may be obtained from the BAC Secretariat on **October 19- November 7, 2017** upon payment of a non-refundable fee stated above. Attendees to the Pre-Bid Conference are only the prospective bidders who have bought bid documents or their authorized representative. All Bids must be accompanied by a Bid Security in the amount not less than the amount provided hereunder:

- Cash, Cashier’s Check, Manager’s Check, Bank Draft - Two Percent (2%) of ABC
- Bank Guarantee (from universal and/or commercial bank) - Two Percent (2%) of ABC

PANELCO I reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
