Compliance with EO # 398, a. Proof of VAT payment for the past six months. b. Tax clearance from the BIR for the last two quarters, h.) On-going, completed or awarded centract not yet started within the relevant period specifying the following; 1.) Name of the contract, 2.) Date of contract, 3.) Amount of contract and value of outstanding contracts, 4.) Date of delivery and 5.) End-user's acceptance if completed. Accreditation is subject to a non-refundable fee amounting to One Thousand Five Hundred Pesos (Php 1,500.00). Original copies of mentioned documents must be presented for proper authentication.
