***All permits must be accomplished by the Contractor**

To be eligible to bid for this Contract, a contractor must meet the following major requirements, to wit:

- Filipino citizen or 75% Filipino-owned partnership/corporation with PCAB license for Size Range **Medium B**,
- Completion of a similar contract costing at least 50% of the ABC, and
- Net Financial Contracting Capacity (NFCC) at least equal to 10% of the ABC.

“Remove and replace” system shall be applied, thus, demolition expenses must be included in the ABC.

ZANECO will use non-discretionary “Pass/Fail” criteria in determining the eligibility of bidders.

All Bidders shall be required to include the cost of all taxes such as but not limited to Value Added Tax (VAT), income tax, local taxes and other fiscal levies and duties which shall be itemized in the bid form and reflected in the detailed estimates. Such bids, including taxes, shall be the bases for bid evaluation comparison and for determining the **Lowest Calculated Bid**.
