Bids received in excess of the Approved Budget for the Contract (ABC) shall be automatically rejected in bid opening. Bids must be accompanied by a bid security payable to the procuring entity as guarantee that the successful bidder shall enter into contract from receipt of the Notice of Award, in the form of Cash, Cashier's check, and Manager's check amounting to 2% of the Approved Budget for the Contract stated under Letter D of the Guidelines On Public Bidding.

Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, under V. Public Bidding A-4.a of RA 10531 the Guidelines on Public Bidding.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives, pursuant Rule II, Section 5 (I) of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531, otherwise known as the National Electrification Reform Act of 2013.
