Resolution Declaring Failure of Bidding

WHEREAS, South Cotabato II (SOCOTECO II) posted the Invitation to Apply for Eligibility and to Bid of the Procurement of 1-20/25 MVA Substation & 1-30/43.75 MVA Substation with SCADA in the national newspaper and a conspicuous place at the premises of SOCOTECO II Main Office;

WHEREAS, during the Eligibility and the opening of bids on May 2, 2017, there are five (5) bidder namely Asia Phil; Ebatech; PPI Pazifik Power; MN Electro and AT & E, submitted their respective bids;

WHEREAS, upon opening of their eligibility envelope, Asia Phil, Ebatech and AT & E bidders were found to be Ineligible since they failed to submit the complete documentary requirements as stated in the bidding documents, resulting to only two bidders successfully passed the eligibility requirement however failed in the bid proposal for it exceeds the Approved Budget of the Contract particularly in LOT A, LOT B and LOT D.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to declare a **FAILURE OF BIDDING** for the *Procurement of 1-20/25MV Substation (LOT A & B) and 1-30/43.75 MVA Substation (LOT D only)*.

RESOLVED FURTHER, the purchase of bid documents made by the five bidders shall not be considered valid for the next scheduled bidding.

RESOLVED FINALLY, at the Seminar Hall, SOCOTECO II J. Catolico Ave., Lagao, General Santos City, this 22th day of May 2017.
