- 3. Must have attended the Pre-Bid Conference. Only prospective bidders who have bought bid documents can attend the Pre-Bid Conference.
- 4. Bidder must have posted a 2% Bid Bond in cash or Manager's check.
- 5. Eligibility of bidders shall be determined using a non-discretionary "pass/fail" criteria.
