1. The *Lanao del Norte Electric Cooperative, Inc. (LANECO)* through its BIDS & AWARDS COMMITTEE (BAC), invites suppliers to apply for eligibility to BID for the Supply and Delivery of Steel and Wood Poles needed for the replacement, extension, rehabilitation and buffer stock of the Cooperative through consignment basis charged to Reinvestment Fund for Sustainable CAPEX (RFSC) and/or General Fund.

3. The Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail criterion as specified in the implementing Rules and Regulation (IRR) of the Republic Act (RA) 10531.
4. Interested Bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below during office hour, Monday to Friday before the opening of Bids.
5. A complete set of Bidding Documents will be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the corresponding amount stated above.
6. The first Delivery Schedule of the Steel and Wood Poles (1 full truck load/container van) will be made within forty five (45) days after receipt of the Notice to Proceed and the remaining quantity will be delivered upon advice by LANECO.
7. LANECO will hold a Pre-Bid Conference (date and time stated above) at LANECO Boardroom, LANECO, Sagadan, Poblacion, Tubod, Lanao del Norte, which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).
8. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY AND DELIVERY OF STEEL AND WOOD POLES.**
9. *The Lanao del Norte Electric Cooperative, Inc* reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
