A complete set of Bidding Documents may be purchased starting **June 27, 2017 until 4:00 P.M. of July 5, 2017** by eligible bidders upon submission of a written application to the BAC Secretariat at the above address and upon payment of a non-refundable fee of Five Thousand Pesos (P5, 000.00). Questions and clarifications regarding the bid documents must be submitted on or before **July 5, 2017**.

Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. Pre-bid Conference will be held on **July 6, 2017 9:00 A.M.** at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on **July 19, 2017 not later than 9:00A.M.** at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
