**INVITATION TO PARTICIPATE IN THE COMPETITIVE SELECTION PROCESS (CSP)
FOR THE ELECTRICITY SUPPLY AND TRANSFER AGREEMENT (ESTA) WITH DORECO
INVOLVING THE FINANCING, CONSTRUCTION, OPERATION AND MAINTENANCE OF AN
11 MEGAWATT BUNKER-FIRED DIESEL POWER PLANT WITHIN THE FRANCHISE AREA
OF DORECO**

(These types of diesel engines should be in a brand new condition and strictly Made in Europe or USA with a fuel consumption rate of not greater than 0.25 liter/kwh and equipped with a black start provision or an independent starting component in the absence of an external power source.)

1. Completion of construction and commissioning of the DPP is required within one hundred eighty (180) calendar days reckoned from the issuance of the Notice to Proceed by the DORECO.
2. Bidding will be conducted through Open Competitive Bidding Procedures using non-discretionary Pass/Fail criterion. Bidding is restricted to Filipino citizens, sole proprietors, partnerships, corporations or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
3. A complete set of Tender Documents may be purchased by interested prospective NPPs from the above stated address and upon payment of a non-refundable bidding fee in the amount of Seventy-Five Thousand Pesos (P75, 000.00).

Other particulars relative to this CSP shall be in accordance with existing applicable government laws and directives.
