## INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Quezon I Electric Cooperative, Inc. (QUEZELCO I) invites sealed Bids from Interested Bidders for the :

### Lot 1 Supply and Delivery of Transformers for 1<sup>st</sup> Qtr. of 2017 for Maintenance Use

Php 2,367,675.00

Bids higher than the ABC shall automatically be rejected.

Bidding will be conducted through open competitive bidding procedures in accordance with the criteria specified in the Implementing Rules and Regulations of R.A. 9184, otherwise known as the Government Procurement Act. Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine its responsiveness to the technical and financial requirements of the project. The contract shall only be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post qualification procedure.

Interested Bidders may purchase bidding documents from June 5, 2017 (8:00 am to 5:00 pm) and until 12nn of June 6, 2017 at a non-refundable cost of Four Thousand Pesos (P4,000.00)/lot/bidder for Lots with ABC of less than Php 3,000,000. Bidders are required to attend a pre-bid conference to be conducted at QUEZELCO I Boardroom on June 6, 2017 at 1:00 PM where technical requirements will be discussed.

All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid. This bid security shall be valid for at least 90 days starting from the date of bid opening.
