

A complete set of Bidding Documents may be purchased by interested bidders from April 6, 2017 to May 2, 2017 at DASURECO Main Office upon payment of a non-refundable fee for the bidding documents. Interested bidders may obtain further information from the DASURECO BAC Secretariat through telephone no. (082) 553-3589. Only those who have purchased the bidding documents shall be allowed to participate the pre-bid conference.

The Eligibility Check and Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations of Republic Act 10531 otherwise known as National Electrification Act of 2013. Post-qualification of the lowest calculated bid shall be conducted.

Sealed bids must be submitted to the BAC Secretariat on the opening of bids scheduled above and will be opened in the presence of the bidders' authorized representatives. Late bids shall not be accepted.

The DASURECO reserves the right to accept or reject any bid to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
