Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Procurement Guidelines and Simplified Bidding Procedures for electric Cooperative, pursuant Rule II, Section 5 (I) of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531, Otherwise known as the National Electrification Reform Act of 2013.
