

INVITATION TO RE-BID

The Aklan Electric Cooperative, Inc. (AKELCO) invites all interested bidders to submit bid for the **ACQUISITION OF A LEASE-TO-OWN SCHEME OF TOOLS AND EQUIPMENT FOR METER READING, BILLING AND COLLECTION, FIBER OPTIC NETWORK AND SERVICES FOR THE KEY OPERATIONS OF AKLAN ELECTRIC COOPERATIVE, INC.** with an Approved Budget for the Contract in the amount of **Sixty-Eight Million Five Hundred Ninety Six Thousand Eight Hundred Ninety Six Pesos (PhP 68,596,896.00)** payable monthly in the amount of **Five Hundred Seventy One Six Hundred Forty Pesos and 80/100 (PhP 571,640.80), inclusive of 12% VAT.** Source of fund is EC's General Funds.

The proposed project is a lease-to-own scheme of tools and equipment to be used in Meter Reading, Billing and Collection transactions along with the Fiber Optic technology connecting all area offices for a real time data exchange in-line with the preparation for the Automated Metering Infrastructure and SCADA System of AKELCO. The project intends to lease and own the tools and equipment for Meter Reading, Billing, and Collection with Fiber Optic Network that will provide the following;

The bidding will be conducted through competitive bidding procedures using the non-discretionary "Pass/Fail" criterion as provided for in the IRR of RA 10531.

Commencement of work for the First Phase of the Project is within fifteen (15) days after issuance of Notice to Proceed and full implementation of the project shall be before June 2017. Second Phase of the project shall be completed before December 2017.
