The BAC will conduct post qualification of the lowest calculated bid. All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of RA 10531 and its Implementing Rules and Regulations (IRR) with conformity to RA 9184 (Government Procurement Reform Act).

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the Instruction to Bidders (ITB).

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address stated above.

Request for clarification on any part of the bidding documents or for an interpretation must be in writing and submitted to the BAC Secretariat ten (10) calendar days before deadline set for the submission and receipt of bids.

Late Bids shall not be accepted.

The ILOILO I ELECTRIC COOPERATIVE, INC. reserves the right to reject any or all bids, declare a failure of bidding, without offering any reason, waive any defect therein and make an award to the bidder whose proposal is most advantageous to the cooperative.
