- 6. CASURECO III will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at CASURECO III Function Room, San Isidro, Iriga City which will be open to all interested parties who qualify and who have purchased bidding documents.
- 7. The Delivery Schedule/Completion of Project is within One Hundred Twenty (120) days upon receipt of Notice of Award (NOA).
