**INVITATION TO SUBMIT ELIGIBILITY DOCUMENTS AND
COMPARATIVE TECHNICAL AND FINANCIAL PROPOSALS
(SECOND COMPETITIVE SELECTION PROCESS)**

The Romblon Electric Cooperative, Inc. (ROMELCO) has received a proposal from Cantingas Mini Hydro Power Corporation (CHPC) to provide full service power supply with the installation of 4.770 MW Wind-Diesel Hybrid Power System in Romblon Island. This will be through the installation of a Wind-Diesel Hybrid Power System with the initial set up of 2.370 MW Diesel Power Plant and 900kW Wind Power Plant. The additional 1.5 MW capacity of the fraction of the offer of CHPC shall be installed not later than the 4th quarter of 2019 or upon written notice of ROMELCO, under the same terms and conditions provided in the Power Supply Agreement (PSA), subject to the approval of the Energy Regulatory Commission (ERC) and completion of all requisite, government permits and licenses. The PSA shall be for a period of fifteen (15) years from commercial operation of the power plants, subject to the ERC approval of PSA and completion of all requisite government permits and licenses.

Upon evaluation, said proposal was found to be acceptable and responsive to the power requirements in Romblon Island for the period above-stated based on its projected load profile and demand growth for the same period. ROMELCO conducted a Competitive Selection Process (CSP) for this original proposal of CHPC thru SWISS Challenge. However, during the submission and opening of bid proposals on January 17, 2019, no bid proposal was received and ROMELCO approved the declaration of the failure of bidding.

Thus, ROMELCO through its Third Party Bids and Awards Committee (TPBAC), is again soliciting offers to challenge the Proposal of CHPC, as Original Proponent, to supply for a period of 15 years, a 4.770MW Wind-Diesel Hybrid Power System through an initial set up of 2.370MW Diesel Power Plant and 900KW Wind Power Plant to commence operation on July 1, 2019, in compliance with ERC Resolution No. 13 Series of 2015 for Competitive Selection Process (CSP).

The rules and procedures for the Competitive Challenge to be adopted by ROMELCO as well as the minimum requirements in "Terms of Reference" or "TOR" for the PSA it shall enter into are

provided in the Terms of Reference for Competitive Challenge of Unsolicited Proposal for the Supply of Power to ROMELCO for Romblon Island (Terms of Reference) which may be purchased by interested power generators upon payment of non-refundable fee in the amount of PhP 200,000.00.

Comparative Financial Proposals that are higher than the Blended tariff rate for each Wind-Diesel Hybrid Power System specified in the TOR shall be rejected outright.

The Comparative Technical Proposals containing the Comparative Proponent's offer as to the terms of the contract must also meet each of the minimum requirements of ROMELCO under the Terms of Reference (TOR)

Comparative Proponent with the lowest offered price and whose technical proposal meets the minimum requirements in the TOR, shall be declared as the Most Responsive Comparative Proponent and its Comparative Proposal shall be subjected to Original Proponent's right to match.

ROMELCO reserves the right to accept or reject any participant or bid, to waive any defect contained in the bid, and accept an offer most advantageous to it, ROMELCO nor any of its member-consumers do not assume any liability or obligation to compensate or indemnify participants for any expense, liability or loss as a result of their participation in the Competitive Selection Process.
