Sealed proposals together with its electronic copy shall be submitted in two (2) sealed envelopes clearly marking as "Original Bid" and "Copy of Bid" with the name of the project to be bidded and the name of the bidder in capital letter addressed and/or submitted to the BAC Chairman during the Bid Opening which will be opened and read in the presence of Bidders or their representative. Bid proposals must include terms of payment, bid validity and delivery schedule.

Further, a two percent (2%) bidder's bond is mandatory required, which is to be returned immediately after the bid awarding.
