Bids received in excess of the ABC shall be automatically rejected in the Bid Opening.

Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project to be bid. The description of an eligible bidder is contained in the Bidding Documents and Instruction to Bidders.

Bidding will be conducted through Open Competitive Bidding Procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 10531.

Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications. A compulsory attendance during the Pre-Bid Conference is hereby enjoined.

All bids submitted must be accompanied with a bid security, in the amount equivalent to 2% of the ABC.

A valid PCAB License is required for the project to be bid with size range **Medium A** and License **Category B** which specializes in electrical works.
