Deadline for the submission of the eligibility requirements will be on or before **August 20**, **2019 at 12:00 NN**. Bidders are also required to submit to the **BAC**. Technical and Financial proposals in separate envelopes properly marked and sealed which will be opened on the date of bidding in the presence of all participating bidders.

All particulars relative to eligibility, bids evaluation and awards shall be governed by the provisions of the coop's policy on Procurement through Public Bidding.

The BAC reserves the right to reject any and/or all bids, declare a failure of bidding or not award the bid for any justifiable and reasonable grounds where the award of the bid will not redound to the benefits of the cooperative and that the LUELCO shall not be liable for whatever expenses the bidder may incur in the preparation of this bid.
