(CEBECO III) through its Bids and Awards Committee (BAC), hereby invites all interested manufacturers, sellers, suppliers, dealers, or authorized franchise dealers who are clothed with a Valid accreditation certificate duly issued by cebeco iii to submit its bids for the Supply and Delivery of **Two (2) Units Brand New 4-Tonner 4x4 Boom Truck with Attached Telescopic Crane, Auger and Bucket** more particularly described as follows:

All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. The submitted documents of each bidder shall be examined and checked for completeness against a checklist of eligibility requirements to ascertain if they are all present using a non-discretionary "pass/fail" criterion.

Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. The prospective bidder must have completed within the last three (3) years from the date of submission and receipt of bids a Single Largest Completed Contract (SLCC) similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.

The presence of bidders during the Pre-bid Conference is **MANDATORY**.

The complete set of Bidding Documents may be acquired by duly accredited bidders of CEBECO III during office hours (8:00am – 5:00pm) upon payment of a non-refundable fee as indicated above.
