The Pre-Bid Conference shall be held at **SIARELCO Main Office, Catabaan, Dapa, Surigao del Norte** on October 23, 2019, 2:30 o'clock in the afternoon. Only interested bidders (and/or authorized representative/s) who have purchased the Bid Documents and submitted a letter of intent are allowed to participate in the Pre-Bid Conference. Failure of the Bidder to attend the Pre-Bid Conference as scheduled shall automatically mean a waiver of their right to question any provision of the Bidding Documents.

Submission, Receipt, and Opening of Bids shall be on November 4, 2019, 2:30 o'clock in the afternoon at **SIARELCO Main Office, Catabaan, Dapa, Surigao del Norte**.
