Bidding schedule will be as follows:


- Advertisement - October 29, 2019 (Philippine Daily Inquirer & NEA Website)

- Opening of Bids - November 18, 2019 (9:00 AM)
- Notice of Award - 7 days from the date of confirmation of the Lowest Calculated & Responsive Bid
- Contract Preparation & Signing - Within 5 working days after issuance of Notice of Award
- Notice to Proceed - Within 5 working days after Contract Signing

Bidders are required to attend a pre-bid conference to be conducted at QUEZELCO I Boardroom on November 5, 2019 at 1:00PM.


All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid.
