

# **CAMARINES SUR I ELECTRIC COOPERATIVE, INC.**

## **INVITATION TO BID FOR THE SUPPLY AND INSTALLATION OF AIR-CONDITIONING EQUIPMENT FOR THE 3-STOREY OFFICE BUILDING OF CASURECO 1 MAIN OFFICE.**

- 1. CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I) through CASURECO I's General Fund intends to apply the sum of Three Million Nine Hundred Sixty-Nine Thousand Pesos (Php 3,969,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Installation of Air-Conditioning Equipment for the 3-Storey Office Building at CASURECO 1 Main Office. Bids received in excess of the ABC shall be automatically rejected at bid opening.**
- 2. CASURECO I now invites bids for the Supply and Installation of Air-Conditioning Equipment for the 3-Storey Office Building at CASURECO 1 Main Office. The Approved Budget for the Contract (ABC) Php 3,969,000.00.**

Delivery of the Goods is required within **Thirty (30) Calendar Days upon receipt of Notice to Proceed**. Bidders should have completed within **Three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act" and National Electrification Administration Memorandum No. 2017-19 "Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531".**

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines,

- 4. Interested bidders may obtain further information from CASURECO I and inspect the Bidding Documents at the address given below starting November 15, 2019 during Monday to Friday from 8:00 A.M. to 5:00 P.M. (except Saturdays, Sundays and Holidays) and from 8:00 A. M. to 12:00 P.M. on December 4, 2019.**
- 5. A complete set of Bidding Documents may be purchased by interested Bidders on November 15, 2019 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of PHP 5,000.00.**

6. **CASURECO I** will hold a Pre-Bid Conference on November 22, 2019 1:00 PM at CASURECO 1, Main Office, PuroBatia, Libmanan, Camarines Sur, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before 1:00 PM of December 4, 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on 1:30 PM of December 4, 2019 at CASURECO 1 Board room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. All activities related to the bidding process will be conducted at CAMARINES SUR I ELECTRIC COOPERATIVE, INC. Main Office, Puro-Batia, Libmanan, Camarines Sur.
9. CASURECO 1 reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
