The proposals of bidders found eligible will be opened and read on the same date and time in the presence of the Bidders or Bidder's representatives who choose to attend, otherwise, they will be returned unopened to ineligible bidders.

All bids submitted must be accompanied by a bid security, in cash or manager's check, in the amount equivalent to two percent (2%) of the amount of Approved Budget Cost (ABC). This bid security shall be valid for at least 150 days, starting from the date of the bid opening.
