

Bidders are required to attend a pre-bid conference to be conducted at QUEZELCO I Boardroom on January 17, 2020 at 1:00PM.


All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid.
