- 6. Diagonal/ Horizontal luminous caution stripe (black & yellow) 5ft from the butt of the pole.
- 7. ZANECO name and pole length shall be painted 5ft from the luminous caution stripe (bold type).
- 8. All steel pole's top cap shall have engraved manufactured date, pole height/length and ZANECO name
