Interested bidders are required to attend the Pre-Bid Conference and only those who have purchased the Bidding Documents shall be allowed to participate and raise or submit written queries or clarifications. Representative must have a written authorization duly notarized (at the principal address) during the Pre-Bid Conference and Bidding proper.

SAMELCO I reserves the right to reject any and all bids, to declare a failure of bidding, or not award the contract, to waive any formality thereof and to accept only such bids that are advantageous to the cooperative without incurring any liability to affected bidder. The decision of the Bids and Awards Committee is final and binding.
