All interested bidders may secure bid documents from BAC Secretariat upon payment of non-refundable fee of **Ten Thousand Pesos (Php 10,000.00)** for SCADA and SF6 Circuit Breaker respectively and **Twenty Five Thousand Pesos (Php 25,000.00)** for the Construction of 1-20 MVA Baluarte Substation. For non-accredited contractor/bidder, they will be required to post a **non-refundable Accreditation fee amounting to Five Thousand Pesos (Php 5,000.00)** for SCADA and SF6 Circuit Breaker respectively and **Ten Thousand Pesos (Php 10,000.00)** for the Construction of 1-20 MVA Baluarte Substation **that will be valid for one (1) year**. Posting of bid bond is either in the form of cash or manager’s check or bank guarantee which is equivalent to two percent (2%) of total bid proposal. The bidding activities will be held at the NEECO 1 Board Room, Main headquarters, Bo. Malapit, San Isidro, Nueva Ecija.
