Sealed proposals must be received by the BAC at the TARELCO I office on **March 27, 2020 not later than 2:00P.M.** at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
